PURPOSE

The purpose of the camp is to sharpen your skills as an official and strengthen five areas that are foundational to the success in officiating.

1. Play Calling
2. Court Presence
3. Fitness
4. On and Off Court Responsibilities
5. Personal Qualities – Character and Integrity

This camp is for any official, regardless of level of experience, who wants to improve and sharpen his or her officiating skills. You will learn game control, preventive officiating, individual problem-solving and 3-person mechanics; and you will officiate high school varsity games. Immediately following your game, you will be accompanied by your evaluator for a video critique of your floor work.

This camp will be a three-day training program designed to provide you with intense instruction on topics covering officials' mechanics, rules of the game and officiating as a business. Classroom style day clinics will help prepare you to officiate your live evening games.

Pac West Supervisor and Coordinator of Officials (Men & Women) will be observing camp attendees and recruiting officials to officiate in the 2010-2011 local Pac West season.
